Updated April 18, 2024

For Spring 2024, City Council will consider a transit-support package to support the Project Connect Federal Transit Administration application as well as a continuation of the HOME Initiative. The [Land Development Code \(LDC\) Amendments](#) for this spring include:

- South Central Waterfront Combining District & Density Bonus Program
