



# COMMERCIAL FACILITY IRRIGATION ASSESSMENT COMPLIANCE PLAN FORM

This form must be submitted if a property is unable to successfully pass an **Irrigation Inspection** prior to the expressed due date and as a result, is required to turn the irrigation system off, permanently disable the irrigation system, or disable parts of the irrigation system.

A Compliance Plan serves as an alternate method of complying with Austin City Code 6-4-10, *Water Conservation, Facilities Regulated* and avoids the accumulation of fines. The Compliance Plan Form must contain the account holder’s name, address and a plan to bring irrigation on the property into compliance.

### SOME EXAMPLE ACTIONS INCLUDE:

- Turning off the entire irrigation system until it can be brought into compliance.
  - o This scenario does not require submitting a map or Irrigation Assessment Form
- Permanently disabling or turning off the irrigation system.
  - o This scenario does not require submitting a map or Irrigation Assessment Form
- Turning off certain zones that have not passed inspection so the system as a whole is in compliance.
  - o This will require the submittal of the Compliance Plan form; **and**
  - o A map showing which stations have been turned off; **and**
  - o An Irrigation Assessment Form completed by an Austin Water Authorized Irrigation Inspector indicating passed and failed stations.

**Please be advised that only those portions of the irrigation system which have passed the inspection are allowed to operate.** Returning failed irrigation stations to operation will require re-inspection of those stations by an AW Authorized Irrigation Inspector.
